### FORESTRY COMMISSION NAMES NEW STATE FORESTER

Scott Phillips has been named the next State Forester of the SC Forestry Commission.

Mr. Phillips, the Rural Forestry Programs Manager with the Commission, will take office when current State Forester Gene Kodama, who has the third-longest tenure of his predecessors, steps down January 2, 2018. Commission Chair Walt McPhail, said, "Scott is a topnotch forester who has both the technical knowledge and people skills to work with the diverse coalition of stakeholders we serve, the landowners growing our forests, the General Assembly, our natural resource partners and of course, our

Rep. Hiott, from Pickens serves as Chairman of the House Agriculture, Natural Resources and Environmental Affairs Committee. He has served in the House since 2005 and is a strong supporter of agribusiness. Rep. Hiott sponsored legislation that allowed the SC Department of Agriculture to be the regulatory authority for the new Produce Safety Rule and worked to pass legislation to update regulations on the poultry industry.

Mr. Roquemore is a past Chairman of the PABC Board of Directors. His business dates back to 1894 and has grown from a smalltown general store in Lakeland, Georgia to a cooperation having a number of sod and seed farms located throughout South Carolina, North Carolina and Geor-

Mr. Summers said "These two state leaders have consistently been advocates for our state's agribusiness interests, and this special recognition is well deserved."

### DOMINION PRESENTS GRANT TO FORESTRY ASSOCIATION OF SC

Forestry Association of South Carolina President Cam Crawford was presented a \$5,000 grant awarded by Kristen Beckham, External Affairs Representative for Dominion Energy Charitable Foundation, to support the SC Sustainable Forestry Teachers' Tour. The tour is a graduate level course offered by the Office of Professional Development in Education at the College of Charleston. Teachers in grades kindergarten through 12 can participate, and the course focuses on the importance of sustainable forestry to South Carolina's environment, economy, and quality of life. The program was hosted for the 20<sup>th</sup> consecutive year in 2017 by the Forestry Association of SC, the SC Forestry Commission, and SC Timber Producers Association.

"The Forestry Association really appreciates the grant from Dominion Energy. Dominion's support will allow us to train additional teachers about sustainable forestry and the importance of South Carolina's \$21 Billion forest industry" said Mr. Crawford.

Through the financial support of the forestry community in South Carolina and other funding sources such as Dominion Energy, the weeklong tour is offered at no expense to the participants. It is designed to educate teachers about all aspects of growing and managing forests, timber harvesting, and the manufacturing of forest products. Over 575 teachers have completed the course since its inception, representing schools from across South Carolina.

## KEMP MCLEOD NAMED 2017 FARMER OF THE YEAR

Kemp McLeod, President of McLeod Farms, was selected as the state winner of the Swisher Sweets/Sunbelt Expo Southeastern Farmer of the Year.

A farmer for 44 years, Mr. McLeod's farm encompasses 7,500 acres, 2,500 acres of rented land and 5.000 acres of owned land. The farm grows peaches on 1,000 acres, which yield 500 bushels per acre. Strawberries from 50 acres yield 30,000 pounds per aces. The farm also grows soybeans, corn, wheat and blackberries. The farm is involved in agritourism, offering festivals and field trips.

A Clemson University graduate, Mr. McLeod was a commissioner of the Chesterfield County Conservation District and was named Outstanding Farmer in the county. He is a member of the McBee Town Council and has been on the Chesterfield County Economic Development Board. He also received the Order of the Palmetto, honoring his contributions to the state of South Carolina.
